WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution **Tungabhadra B.P.Ed College, Vidya Nagar, Bangalore Road, Kottur, Bellary - 583134, Karnataka** has by affidavit consented to come under New Regulations and sought for 100 intake in B.P.Ed.

3. AND WHEREAS, on scrutiny it is found that the reply of the college to the letter dated 01.07.2003 issued by SRC, NCTE is not submitted.

4. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 100 students (two sections of 50 each) subject to the decision of the SRC on the reply to be submitted by the college to the letter dated 01.07.2003 sent by Regional Director, SRC before 30.06.2015 and the institution fulfilling following conditions namely,

- I. The institution shall submit reply to the points raised in the letter dated 01.07.2003 before 31.07.2015 with documentary proof failing which recognition will be withdrawn.
- II. The institution shall submit the documents before 31.10.2015, with documentary proof failing which recognition will be withdrawn.
- III. The institution shall appoint additional staff as per Regulations, 2014 and submit approved staff list to the Regional Committees with required documents by October 31, 2015.
- IV. The Regional Committees shall arrange for verification of documents, check adherence by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with the new teaching staff requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.



- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students.
- f) Available infrastructural facilities.
- g) Facilities added during the last quarter.
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.




